

Reverse engineering a social order

Engineering - The application of scientific and mathematical principles to practical ends such as the design, manufacture, and operation of efficient and economical structures, machines, processes, and systems.

Reverse Engineering is the application of scientific and mathematical principles to discover and document the design and operating model of a structure, process, machine, or system.

In the social context, reverse engineering is used to discover and document the design and operating model of the social order. In most if not all societies, the description of the social architecture and operating model do not reflect the real architecture and operating model. This is a huge problem because the citizenry are taught (culturally programmed) to believe that the social order is functioning in a manner that is not real. This means that any efforts that the citizenry may make to change the social order will not be effective i.e. they will intend to make changes to create a more egalitarian society however their solutions and plans to do so will be based on an unreal understanding of the current state of the social order. This means they cannot create realistic solutions or roadmaps to get from current state to future state.

This is described best using a simple model.

1. The people are taught that they exercise political power (and therefore control) in their social order through voting.
2. But the voting process is compromised by various manipulations of those who administer and those who influence those who administer the voting process so that the end result does NOT reflect the will of the people
3. Further, enough of those who are voted into office are compromised and controlled using the social control mechanisms of the wealthy and powerful so that the social institutions represent and support the interests of the wealthy and powerful and NOT the general population.
4. The result is that if people insist that they can create effective social change through voting, then the people will never be able to effectively create social change.

In this case efforts for true change, true revolutionary energy, is channeled into an activity which cannot be used to make changes in the social order.

In the broader context this activity does not address the ability of the wealthy and powerful to manipulate the minds of the general population using social control mechanism such as terrorizing the general population through false or misleading information, terrorizing the general population through false flag attacks against the country, terrorizing the general population by threatening loss of jobs, distracting the general population through corporate controlled media (TV, movies), bribing the general population with promises of jobs and security (after threatening them with the loss of both).

Especially in a capitalist system, the "democratic process" cannot control the economic system,

and yet true power lies in control of the economy.

“Permit me to issue and control the money of a nation and I care not who makes it’s laws.”

2005 - There are now only 5 nations in the world left without a Rothschild controlled central bank: Iran; North Korea; Sudan; Cuba; and Libya.

The voting process also does not address the ability of the wealthy and powerful to exert control over the legislative process by using social control mechanisms (bribes, threats, intimidation, assassination, promises of prestige and power) to manipulate the legislative representatives into passing laws and regulations which benefit the wealthy and powerful. e.g. The congress votes to provide a 700 billion dollar bailout package for the banking institutions (corporations) with the stated intent of having the banks start lending that money out to reset and improve the economy. However there is no provision made to make the bankers lend the money or for them to account for what they do with it. So the bankers take the money and put it in their own pockets to cover their own losses in the stock market. Congress does nothing about it because the majority of the members of congress have either been bought off, have stock in those financial institutions and don't want to loose their own money regardless of the suffering of the general population who are loosing jobs and homes, or have been threatened or intimidated into complying with the bailout action.

In this scenario, what difference does any kind of vote make? None.

So what would a reverse engineering effort find? The resulting model would show the manner in which the architecture of the government is set up to represent and satisfy the interests of the wealthy and powerful.
